## Loan Conditions

Aid equipment is loaned on an individual basis. You may not lend or transfer your aid equipment to another person. Your loan of the aid equipment is registered with the care-provider. The prescriber is the person working within the healthcare service who is responsible for the assessment, testing and monitoring of the loan. The prescriber reserves the right to perform a renewed assessment of your need for aid equipment – for example, in the event of changes to the state of your health or your housing conditions, or if you do not use the equipment in the way that it was intended. A renewed assessment may result in the prescriber withdrawing or replacing the loaned equipment.

## Instructions, user manual, and care and maintenance

It is your responsibility to use, maintain and clean the aid equipment in accordance with the stipulations of the user manual and the instructions provided by the prescriber. This is in order to ensure that the aid equipment functions in the correct manner and is not subjected to abnormal wear and tear (including, e.g., charging batteries, cleaning the equipment, inflating tyres). The aid equipment must be stored in an appropriate location. You may not make any modifications or adjustments to the loaned equipment.

## Repairs

If your aid equipment should require repair, you must contact the stated prescriber/contact person. If you suspect that the fault may compromise safety, you must not use the equipment until the issue has been rectified.

## Moving home/ change health center

If you are planning to move/change your residence/ change health center, you must contact the stated prescriber/contact person for information plenty of time in advance.

## Liability

You may be held liable for costs if the aid equipment is damaged (beyond normal wear and tear), if it is lost due to your negligence, or if it is returned in a state of unusual dirtiness. You may also be held liable for costs if you use the aid equipment in any way that deviates from its intended use, not returned after a loan period or after moving from Norrbottens County where the receiving aid operation do not take over responsibility for the aid.

## Insurance

When you borrow aid equipment, it is recommended that you contact your insurance company in order to review the extent of your insurance cover with regard to (for example) theft, fire and any other form of unexpected damage caused to the equipment. The theft of, or any damage caused to, the equipment must be reported to the police, and the prescriber must also be informed. Prior to any travel abroad, we recommend that you contact your insurance company in order to review the extent of your insurance cover with regard to any aid equipment that you will be taking with you on your journey.

### **Travelling**

In the event of any damage sustained by the aid equipment when travelling (e.g. via aeroplane, train or färdtjänst/mobility transportation service) you must – at the time and place of the occurrence – submit a damage report both to the airline/transport operator (or equivalent) and to your insurance company. You must also always contact your prescriber.

Transportation and the cost of any repairs in conjunction with the visit abroad will not be paid for by the care-provider. The borrower of the aid equipment is responsible for such costs – either personally or through their insurance.

### **Return**

When you no longer have any need for the aid equipment, it must be returned as soon as possible, complete with any accessories and in a well-cleaned condition. For information regarding to where the equipment must be returned, contact your stated prescriber/contact person.

### **Incidents concerning the equipment**

If you should experience any incident/accident with your aid equipment, you must contact your prescriber/contact person.
